GENERAL CONDITIONS

1. RESERVATIONS

All reservations are confirmed through Caspian Khazri, a company registered with the Azerbaijan ministry of trade.

No reservation is valid unless Caspian Khazri has received this signed contract via email, accompanied by the required advance deposit, or the total amount due to the camp if less than 15 days separates the date of registration and the beginning of the session.

The person signing the registration form certifies to Caspian Khazri that he/she has the legal right to represent the participant registered (and if the participant is under 18 years of age, the authorisation of the parents, of the group leader or of the legal guardian) and to enter into this contract with Caspian Khazri and that each registered participant accepts all of this contract's conditions.

This contract is governed and interpreted under Azeri laws and jurisdiction.

No addition, deletion, modification or promise can be made regarding these terms and conditions, except in writing, by a representative or director of Caspian Khazri.

2. FINAL PAYMENTS AND REFUNDS

The total programme cost for the session, including charges for supplementary items, must be deposited to Caspian Khazri before the beginning of the camp. The required advance deposit is non-refundable. The balance is refundable up until 15 days before the beginning of the session and after this date is non-refundable, except if you meet point 10 of Les Caspian Khazri general conditions. In the event that a student is expelled from the camp on the groundsof gross misconduct or breach of Caspian khazri Rules (see point 6.), no refund will be given. Caspian Khazri also reserves the right not to refund any camp fee due to students cutting their stay short.

3. EVENTS BEYOND THE CONTROL OF Caspian Khazri

War or risks of war, terrorist activities, political instability, riots, civil wars, industrial conflicts, natural disasters, closing of airports, technical problems or airplane accidents or other transportation accidents, fire, bad weather or any other events, or Acts of God beyond the control of Caspian Khazri that may affect the running of the camp programme, will not be the responsibility of Caspian Khazri. If the direction decides that the camp cannot be run for one reason or another, Caspian Khazri will refund the total amount of money received. If the participant decides on his/her own not to participate in the camp although it will be normally run, the participant cannot claim any refund from Caspian Khazri. Snowboarding can be chosen however in the case a camper is the only one in the class, this shall be deemed a private lesson and therefore incur an extra charge of \$50 per ski day.

4. RESPONSIBILITIES

Caspian Khazri gladly assumes full responsibility for the programme arrangements reserved and will do its best to fulfil these. However, Caspian Khazri cannot be responsible for certain events that are not in control of Caspian Khazri. For example, ski-lifts, certain hotels, airlines or other public transport companies, or other parties such as mountain guides, specialised monitors etc. Therefore, Caspian Khazri clearly states that it cannot be held responsible for extra costs, complications, losses, injuries, damage, accidents, lateness or inconvenience due to any error made by a company, or other persons in regard to the benefits offered in the reservations, during the activities or during transportation of participants unless some negligence or lack of diligence on the part of Caspian Khazri can be proven. If a reservation is made, through an external collaborator or independent agent of Caspian Khazri, all complaints regarding their services should be made directly to the concerned party or parties. Each parent or group leader must sign, date, and return the consent form along with all annexed sheets describing the activities.

5. PARENTAL RESPONSIBILITIES

The parents, the group leader or legal guardians assume full financial responsibility for each participant: they register (children or young adults) for the following:

- A. Damages caused, voluntarily or not, to facilities, equipment, material or other objects belonging to, or rented by, Caspian Khazri.
- B. Costs of repatriation of participants required to return home or to a specified place for reasons of health, accident, bad behaviour or other reasons judged as valid by Caspian Khazri.
- C. Pocket money and all other personal purchases made by the participant except for articles clearly stated in the reservation
- D. All equipment rented or purchased which is deemed necessary for the participant to take full advantage of his/her holiday which is returned by the participant in bad condition or which may be lost, missing or damaged.

6. BEHAVIOUR OF PARTICIPANTS

Whilst under the responsibility of Caspian Khazri, the participants are expected to conform to the rules and regulations of Caspian Khazri. Caspian Khazri reserves the right to send the participant back to his/her home or to his/her group leader, if, during the session, the participant exhibits behaviour which is incompatible with the well-being of the camp or if the participant fails to observe the rules established by Caspian Khazri. Each parent or group leader will sign and return the annexed rules.

7. SKI CONDITIONS

Caspian Khazri cannot be held responsible for weather or snow conditions which may interfere with the ski program. If Caspian Khazri judges that the conditions for skiing are dangerous or unsuitable due to the weather, the ski program may be delayed or cancelled, even if the ski-lifts are functioning. If for any reason the ski season has to be cancelled, substitute activities will be provided for the participants. Only if Caspian Khazri is compensated by refund from the ski-lift central office, will the full amount of any such refund be divided among the participants involved.

8. HEALTH AND ACCIDENT INSURANCE

Health and accident insurance is mandatory. Caspian Khazri has a health and accident insurance for its participants. This insurance is compulsory for each participant who participates with Caspian khazri and includes coverage for all sickness or accidents in Azerbaijan. Pre-existing illnesses will not be covered. The insurance covers only expenses from the moment of arrival in Azerbaijan until the departure from Azerbaijan.

9. CANCELLATION OR MODIFICATION OF PROGRAM

Caspian Khazri reserves the right to cancel any of the sessions mentioned in its brochure due to insufficient numbers of participants or for any other reason at the discretion of Caspian Khazri. If this rare event should arise, Caspian khazri will offer to its participants the possibility of choosing another camp session.

10. PUBLICITY MATERIALS

Caspian Khazri reserves the right to use all photographs of participants, or work completed by participants or other persons, for its future publicity purposes.

11. MEDICAL TREATMENT

Caspian Khazri will take any and all necessary action for the well being and health of the child. This contract authorises Caspian Khazri to take action to assure medical treatment of the child, in the event of accident or injury, at the discretion of Caspian Khazri. All costs of medical treatment will be the responsibility of the parent, the group leader or legal guardian.

12. IMPORTANT

I have understood the information in the brochure of the Caspian khazri Camp in Azerbaijan. I confirmwith my signature that I know my child will participate in sports activities with inherent risks during the course of this camp. Particularly skiing, snowboarding, soccer and (optional) paragliding, mountain roller coaster, 4x4 off road adventure, zip lining, and tobogganing . I also confirm the knowledge that these activities take place under the responsibility of Caspian Khazri monitors and also under the responsibility of companies or third persons carefully chosen and contracted by Caspian khazri. I have understood and signed the consent form in addition to the explanatory note on each activity, with its description, its risks, and the security measures specific to it, the qualifications of the monitors, guides or other person in chargeof taking care of, helping or advising the participants. I accept that these choices are discerning and that the measures are suitable and sufficient. In my role as legal representative of child, I accept these risks and I authorize my child to participate in sports activities under these conditions.
